Note :-

- (1) The student must pay the transportation fee to the respective college at the beginning of the semester only. The students will not be issued bus passes to travel without payment. Fees paid once will not be refunded in any circumstances.
- (2) Bus fare of all the staff will be deducted directly from the salary at the beginning of the semester. All the staff shall fill the transportation form on or before 22nd July 2024, after that the pass will not be issued.
- (3) The transport fare for one day from the cities of Mehsana, Ahmedabad, Gandhinagar and North Gujarat will be as follows.

- (4) If the person is caught traveling in the bus without a valid pass, he/she shall have to pay the penalty as under.
 - a) Rs. 200/- Staff and Students of Mehsana Routes.
 - b) Rs. 400/- staff and students of Ahmedabad, Gandhinagar and North Gujarat city routes.
- (5) The pass must be shown compulsorily when the bus pass is checked in the bus. If any one found without bus pass, the ID card will be seized.
- (6) The staff utilizing the transport facility from North Gujarat Routes, the payment of fare during summer vacation will be applicable as per current practice.
- (7) This circular is applicable for Odd Sem. Dt. 1.7.2024 to 31.12.2024.
- (8) The timings of the Shifts will be : 1st Shift: 8.30 AM to 2.10 PM

2nd Shift: 11.40 AM to 5.20 PM

(9) The Timings of working Saturday will be 09.00 AM to 04.00 PM.



UNIVERSITY TRANSPORT RULES:-

- (1) The bus will depart only if there are at least 20 passengers present to travel. Management reserves the right to change the bus route accordingly.
- (2) The staff must treat the students in a friendly manner. The availability of the seat should not be disputed.
- (3) A Bus Pass is mandatory for all to travel in the university buses.
- (4) Transport facility will be made available on designated routes and stops only, at the sole discretion of the management.
- (5) It is to understand that the transport, like any other vehicle on road, may get delayed sometimes due to traffic conditions, road conditions, or some technical fault. The students/staff should understand these practical situations and they should be at their best in cooperating towards the same.
- (6) The transport routes are subject to change depending upon the requirements of the students and it is at the sole discretion of the management.
- (7) Transport is an optional facility and it cannot be claimed as a matter of right by any student/ parent. The management reserves the right to withdraw the transport facility from any student without assigning any reason whatsoever.
- (8) The transport is arranged by the university for a complete academic session. Thus transport cannot be withdrawn between the academic session.

DISCIPLINARY NORMS IN THE UNIVERSITY BUS:-

The availability of transport facility to the students is subject to adherence to disciplinary norms. Any misbehavior that distracts the driver is a serious violation and could harm someone. Therefore, students are required

- a) to remain seated while the bus is in motion.
- b) to obey the instructions of the Bus Driver/In-charge.
- c) not to throw objects in or out of the bus.
- d) not to use indecent language in the bus with fellow students or the bus staff.
- e) not to damage the seats, curtains, etc. in the bus.
- f) not to fight or threaten other students in the bus.
- g) to abstain from any unruly behavior in the bus.
- h) not to consume prohibited substances during bus journey.

- i) not to use loud speaker in the bus, if it is observed, it will be confiscated and will be dropped in the middle of the journey.
- j) If any student is reported for any of the above violations, the university will withdraw the facility with a fine.
